- 10. Z-10 Municipal Market (Shops & KDA Safari Apartments constructed)
- 11. Z-11 Shops (Rado Hill top Apartments & Shops constructed)
- 12. Z-12 Swimming Pool 4,274sqYards(Encroached by Gold Line Residency & Construction in progress)
- 13. Z-13/1 Maternity Home & Dispensary Centre. (Available)
- 14. Z-13/2 Post Office and Fire Brigade (Post office space available)

We are enclosing all the relevant copies to proof the existence of Amenities in KDA Overseas Bungalows provided to us when the project was announced by KDA.

We seek your help to protect the remaining amenity plots from the mafia as we are continuously struggling hard to save them but in most of the cases not succeed. 
