

**PERMISSION FOR USE OF ROAD FOR INHOUSE WEDDING FUNCTIONS OF RESIDENTS AND THEIR WARDS IN KDA
OVERSEAS BUNGALOWS, BLOCK 16 A, GULISTAN-E- JOHAR, KARACHI**

Sir,

We, Overseas Pakistanis' Bungalows Residents Welfare Association (OPBRWA), elected representative of 400 resident members of subjected society take this opportunity to intimate that our society is a gated housing complex having around 400 houses allotted to Non-Resident Pakistanis in 1985 by KDA through foreign exchange. This project comprises of 11 small parks, a Main Family Park and one Central Sports Ground. Our Central Sports Ground is recently been developed by the Federal Government budget, hence, once a barren park now stands a lush green ground with Flood Lights for the benefit of young and the old of our community.

Furthermore, the main sports ground, being barren was utilized for arranging matrimonial and social ceremonies by and for only the residents.

However, due to development of our Sports Ground, it is not prudent nor economical to allow residents to hold their ceremonies. Moreover, due to the unprecedented CoViD-19 pandemic, our residents are reluctant to hold their ceremonies elsewhere in the city.


We are running a system wherein the Association office is allotting the space of the ground for wedding functions of the residents and their wards who would like to have their functions within the society for security & economical or non-availability of marriage halls on the dates. But now since this ground has been made grassy and converted into Football ground for our children's, we wish that wedding functions be shifted to the adjacent wide road of the ground and Association office which is wide enough to facilitate the residents as most of them likes to have their celebrations within the boundary limits of this complex. Holding of functions in the grassy ground will damage the grass beside other damages and maintaining the ground would be much difficult for us.

In KDA Overseas a part of this main road in front of Association office we have many other roads available for the residents to enter and exit which means no residents will be impacted with the arrangement of function on the specified road within the society. We also have washrooms, dish washing area and other facilities along the wide road to provide facility to residents in organizing their functions and being an Association will ensure to keep the environment healthy.


